The owners reserve the right to apply the following charges


More than 2 months prior to arrival

**Liability**

In the event of any damage to the property, caused by the party to this agreement, the owners or their agents will look to those persons for full reimbursement of the outstanding amount within fourteen days.

By making any payment with a credit card, you authorize Themeland Villas or their Management Company, within fourteen days after guests departure to take any reimbursement deemed necessary, however photographic proof (wherever possible) of damage must be made by Themeland Villas or our Management Company to justify charge to the card. Themeland Villas must also show all incurred costs, invoices and payments as proof of repair, which will be available upon request.

If you do not pay with credit card we require a security bond of \$250, which will be refunded to you within 14 days after your departure, subject to a satisfactory status report by our Management Company Holiday House Management and the safe return of the key/s.
